Prices & Quotations

Quotations are good for immediate acceptance unless otherwise noted, and are subject to change without notice. Clerical and inadvertent errors will be corrected. Applicable taxes will be added as required.

Returns & Cancellations

Orders may not be returned or cancelled without our prior consent, and we reserve the right to apply restocking or handling charges. Returned goods must be in new and unused condition in the original factory cartons. Special orders may not be returned or cancelled unless we have the supplier's consent. Invoice number and date must accompany returned goods.

Shipments & Claims

Please check for damage or shortages before signing for any material. All such claims, or those for pricing or other errors, must be made within 30 days of the invoice date. If shipment is made via common carrier, then damage or shortage claims must be filed by the customer against the carrier.

Invoice Payment & Credit Terms

In case of fire, dissolution, suit or action instituted against you, this invoice is due and payable immediately. All orders are subject to approval of credit department. Prevailing rates of interest may be charged on Past Due Accounts. Title to property listed in this invoice remains in Seller until fully paid for. Buyer agrees to release merchandise unpaid for upon demand by Seller. All legal expense and court costs will be the responsibility of the Buyer.
